

## MINUTES BOARD OF REGENTS MEETING February 25-26, 2016

## Thursday, February 25, 2016

The University of North Texas System Board of Regents convened on Thursday, February 25, 2016 in Founders Hall, Room 138, at the University of North Texas at Dallas, 7300 University Hills Blvd., Dallas, Texas, with the following Regents in attendance: Brint Ryan, A.K. Mago, Don Potts, Rusty Reid, Gwyn Shea, Al Silva, Laura Wright, and Courtny Haning. In accordance with a notice being duly posted with the Secretary of State and there being a quorum present, Chairman Brint Ryan called the meeting to order at 8:02 a.m. Regent Glen Whitley joined the meeting at 9:00 a.m.

Chairman Ryan recognized Chancellor Lee Jackson who reported on 2015 Accomplishments, 2016 Forecast and Major Events, and Goals for the Board Meeting. Following the Chancellor's remarks, UNT Dallas President Bob Mong commented on Community Partnerships, Non-traditional Recruiting, and the Student's First Year Experience. President Mong also introduced the new Dean of the School of Education at UNT Dallas, John Gasko.
