Title: Delegation of Authority to Proceed with Planning and Preparation of an Application for a Branch Campus

Background:

The University of North Texas and the City of Frisco entered into discussions concerning the development of a branch campus to be located in Frisco.

Enrollment at UNT from 2012-2017 indicates that 89% of students are Texas residents with 70% of those coming from Denton, Dallas, Tarrant, or Collin counties. Roughly 17-18% come from Dallas, Tarrant, and Denton counties, and 10% come from Collin County.

Collin County population demographics indicate higher growth in both the traditional undergraduate target ages and the post-traditional, post-graduate, and executive education target ages. UNT currently enrolls 1.7% of Collin County students out of the target cohort. It is estimated that population growth alone will result in Collin County enrollment soon exceeding 5000 students with an incremental increase of 2.750 students by 2027.

The local presence established by the creation of a branch campus will build increased market share of traditional undergraduates, transfer students, and adult learners and is critical to offering programs for post-graduate and executive education.

UNT currently operates a higher education learning center located at 2811 Internet Blvd, Frisco, TX 75034. Programs and classes offered there include Business, Psychology, Education, Kinesiology, Sport Management, Data Analytics, and Applied Arts & Sciences. The current enrollment at the center is 1,347 students.

The creation of a branch campus will offer additional space for programs, classrooms, students, and auxiliary facilities. It is anticipated that initial space planning will be for a minimum of 5,000 students.

The City of Frisco has offered an economic incentive in the form of 100 acres to be given to UNT System for creation of a UNT branch campus.

Title: Delegation of Authority to Proceed with Planning and Preparation of an Application for a Branch Campus

Whereas, to create a branch campus an application must be submitted to, and approval received from, the Texas Higher Education Coordinating Board,

- 1. Preparation of an Application for a Branch Campus to be located in Frisco, Collin County, Texas; and
- 2. The Chancellor and the President of UNT, or their respective designees, to take any and all further action necessary or advisable in planning a branch campus to support preparation of the Application; and
- 3. Contingent upon Board of Regents review and approval of the Application, submission of the Application for a Branch Campus to the Texas Higher Education Coordinating Board.
