#### **Executive Summary**

UNTS is showing a \$111M favorable variance vs. budget [#1].

Revenue [#2] is \$31.1M favorable compared to budget, driven mostly by increase of enrollment at UNT in the Fall and Spring [#3], CCAP being received earlier then expected [#4] and investment and gift income being higher then anticipated [#5].

Expenses [#6] is \$89.9M favorable compared to budget, driven mostly by lower than expected costs in; personnel due to hiring difficulties [#7], scholarships due to a portion of COVID Relief funds expected to be used in FY23, were actually expended in FY22 [#8] and other expenses due to HSC's AIM AHEAD expenses being delayed [#9].

*Transfers* [#10] is \$9.9M unfavorable, driven mostly by CCAP being transferred out to non-current earlier then expected.

#### **Executive Summary**

UNTS is forecasting a \$52.5M unfavorable variance vs. prior year actuals [#1]

Revenue [#2] is projected to end \$21.3M favorable to prior year actuals, driven by increase in UNT's enrollment [#3] and an increase in state appropriations due to CCAP being received this fiscal year [#4].

Expenses [#5] is projected to be \$99.8M unfavorable to prior year actuals, however is \$5.6M favorable to FY23 budget. The variance is driven mostly by an anticipated increase in faculty and staff to support student growth [#6], maintenance expenses to address UNT's campus 'wear and tear' [#7] and HSC's AIM-AHEAD grant layover expenses from FY22 [#8].

Transfers [#9] are projected to end FY22 \$26.0M favorable to prior year actuals, driven by UNT making a transfer to non-current for HEF funded projects in FY22.
